

Greetings from the Foundation office. Becky Schaub and I want to thank you for another successful year. This year's Annual Report is filled with more good news about what has been happening with OUR community foundation.

The Foundation's mission is to improve the quality of life in the Wapakoneta area through organized philanthropy. Philanthropy is defined as the desire to promote the welfare of others through generous donation of money to good causes. Over the past 35 years, many civic-minded individuals, families, businesses and organizations have generously invested in creating 50 donor advised funds and 45 scholarship funds to benefit our community and people. These are perfect examples of philanthropy at work promoting the welfare of others.

We continued to grow and prosper in 2025. We received a major bequest from the Jonathan T. Sweger estate —\$1.3 million—to establish a new scholarship fund. We set new records in scholarship awards -\$349,000 and Community Fund grants -\$170,900. Our investment planning has also been successful. The market value of our assets now exceeds \$14 million. Last year we had the opportunity to celebrate our founding. In April of 1990, the Foundation had two scholarship funds and a cash balance of \$32,802. The good stewardship of past and current board members and the generosity of our donors have been the source of our success. For that, we say THANK YOU!

As we approach the end of the year, our Annual Community Fund Campaign will be underway in December. The campaign goal is to invite local citizens, businesses and civic groups to invest in the fund that enables the Foundation to award our grants. There are details about the campaign in the report. HOW TO LEAVE YOUR LEGACY

TYPES OF FOUNDATION FUNDS

The Wapakoneta Area Community Foundation enables people to set up a charitable fund that gives to a specified organization or cause forever. The fund can be tailored to your interests. You can create a fund now with current gifts or later through your will or other estate planning document. We are here to help you through the planning process. Here are examples of the fund options.

COMMUNITY FUND — Allows donors the opportunity to provide direct financial support for the Foundation's grants programs and operational costs.

DONOR ADVISED FUND — Provides the donor the ability to make contributions to specific charities at the donor's discretion.

FIELD OF INTEREST FUND — Provides the ability to support a broad area of concern to the donor, such as education, scholarships, the arts, persons with personal challenges, or health services.

DESIGNATED FUND — Ensures that support will be provided to a specific not-for-profit organization named by the donor.

AGENCY ENDOWMENT FUND — The Foundation allocates income to the agency on an annual basis as designated by the donor.

GIFT ACCOUNT FUND — A short term donor advised fund that is intended to disburse to the qualified charity the entire amount gifted by the donor.

PROJECT & CAMPAIGN FUND — Designated use, non-permanent fund established only for the duration of a capital project or community initiative.

ANOTHER RECORD-SETTING YEAR FOR SCHOLARSHIPS

The Foundation awarded it first \$600 scholarship in 1990. In 2025, we managed 45 scholarship funds established by various generous donors over the past 35 years. We awarded 199 scholarships to 99 students totaling \$349,000. Students receiving scholarships attended ten regional high schools in Auglaize, Allen and Shelby Counties. Students graduating from Wapakoneta High School received 64% of the scholarships. Our scholarship recipients will be attending 26 different universities, colleges, and certification programs—both on campus and online.

Jonathan Sweger was a 1971 graduate of Wapakoneta High School. He was a member of the National Honor Society. He also participated on the football, wrestling, and tennis teams. He was a Senior Letterman and member of the Varsity Club. After graduating, he went to work as a skilled machinist at the Wapakoneta Machine Company until it closed in 1988. He then went to work as a machine tool builder at Minster Machine until his retirement in 2017. Jonathan was an accomplished bridge player. He competed in bridge tournaments around the country. In 2024, he earned *Gold Life Master* ranking, the highest level in bridge anyone in Auglaize County has received. He died in August 2024. He left his entire estate to the Foundation to establish his scholarship fund. It provides multiple scholarships each year to students in any Auglaize County

high school or home-schooled students. This year, 14 students received \$44,000 in scholarships.

Sean T. Bailey Memorial SCHOLARSHIP

Sean was a 2001 graduate of Wapakoneta High School. He graduated from Bowling Green State University with a degree in geology. He moved to Denver, Colorado and began a career as a professional engineering geologist. He worked for Brierley Associates, a trenchless tunneling company. He worked on projects in New York, Kentucky, Wyoming, Nevada and Colorado. He was very proud of his work on the Lake Mead Intake Project, a major tunnel boring project beneath Lake Mead in Nevada to increase water supply for the Las Vegas area. Sean died on September 30, 2024 at age 41. His family and friends have created this scholarship in his memory. It provides an annual \$1,000 scholarship to a graduating high school senior, attending Wapakoneta High School who plans to major in Earth Sciences, including geology, oceanogra-



phy, environmental sciences, geophysics, geochemistry, paleontology, hydrogeology, mineralogy, petrology, astronomy, or meteorology. Unfortunately, there were no WHS seniors planning to major in Earth Science this year. The family has decided to open the scholarship next year to seniors at any Auglaize County high school.




Kiwanis Club of Wapakoneta Scholarship

A TRULY REMARKABLE COMMUNITY ASSET

The Performing Arts Center was built in 2010 at a cost of \$5.6 million. It was totally funded by local taxes. No state funds were invested in the facility. The people of the Wapakoneta School District chose to fund the building locally.

The theater seats more than 700 people. It has theater-quality lighting and sound systems operated from a control booth at the top of the theater. It was designed to have excellent acoustics and comfortable seating.

The stage is of ample space with an orchestra pit that can be lowered when needed. It also has theatrical rigging space that allows stage crews to hoist curtains, lights, or scenery above the stage quickly and quietly. Back stage there are two dressing rooms, space for scenery construction and storage, and an overhead door to allow for easy unloading and loading from the stage.

It is used for a wide variety of school events for high school, middle school and elementary students. It also hosts many community and regional events each year. On April 12, we discovered it was a perfect venue for a community arts concert!
